Findings:

- 1. The establishment has no grease trap
- 2. The wastes are mixed and not segregated
- 3. Lack of trash bin
- 4. There is a leak of liquid waste to irrigation
- 5. The area is dirty
- 6. Commit violation under R.A 8749 (Clean Air Act) emission of smoke from the chimney
- 7. Non-Compliant to ECC (Environmental Compliant Certificate)

In regards with the above-mentioned issue, MENRO cited the following recommendations to address the said issue. The lists of recommendations are as follows:

Recommendations:

- 1. Establish Water Treatment Facility
- 2. Additional trash bin for solid waste segregation
- 3. Coordinate to (EMB) Environmental Management Bureau for the process of Certificate of
- 4. Cleaning of drainage system
- 5. Installation of sprinklers to the chimney
- 6. Additional requirements for (BOD test & Discharge Permit)
- 7. Must have Air Pollution Control Techniques
- 8. Air Quality monitoring report
- 9. Must have PCO (Pollution Control Officer)
- 10. The permit holder shall submit quarterly self-monitoring report to MENRO

Also, we will conduct quarterly monitoring on the said Establishment to ensure their compliance with the following environmental ordinances:
