Findings:

- Without business permit
- Lack of environmental permits such as certificate of non-coverage (CNC) and discharge permit
- Improper wastes management
- Minimal foul odor

In regards with the above-mentioned issue, MENRO cited the following recommendations to address the said issue. The lists of recommendations are as follows:

Recommendations:

- Coordinate to (BPLO) Business Process Licensing Office for the issuance of business permit
- Secure environmental permits such as CNC (Certificate of Non -Coverage) and discharge permit to the EMB (Environmental Management Bureau)
- Establish 3-layer septic tank for the proper management of liquid wastes
- Practice composting for the biodegradable wastes
- The permit holder shall submit quarterly self- monitoring report to MENRO

Also, we will conduct quarterly monitoring on the said Establishment to ensure their compliance with the following environmental ordinances:

- RA 9003- Ecological Solid Waste Management Act of 2000
- RA 8749- The Philippine Clean Air Act
- RA 9275- The Philippine Clean Water Act
- RA 6969- Toxic Substances & Hazardous & Nuclear Waste Control Act

** We do advise to make an urgent response in addressing this matter as soon as you received this inspection report. Failure to comply with the recommendations given above will result to restricted operation or much worse, closure of the business.*
