Findings:

- Minimal leak of wastes water has seen at the back of the establishment
- Functional water treatment facility
- Lack of environmental permits such as Hazardous Wastes Generator I.D, Discharge permit and ECC (Environmental Compliance Certificate)

In regards with the above-mentioned issue, MENRO cited the following recommendations to address the said issue. The lists of recommendations are as follows:

Recommendations:

- Avoid leakage of wastes water into the field
- Secure environmental permits such as Hazardous wastes generator I.D, Discharge permit and ECC (Environmental Compliance Certificate) to the EMB (Environmental Management Bureau)
- Maintain the cleanliness of the area.

Also, we will conduct quarterly monitoring on the said Establishment to ensure their compliance with the following environmental ordinances:

- RA 9003- Ecological Solid Waste Management Act of 2000
- RA 8749- The Philippine Clean Air Act
- RA 9275- The Philippine Clean Water Act
- RA 6969- Toxic Substances & Hazardous & Nuclear Waste Control Act
