

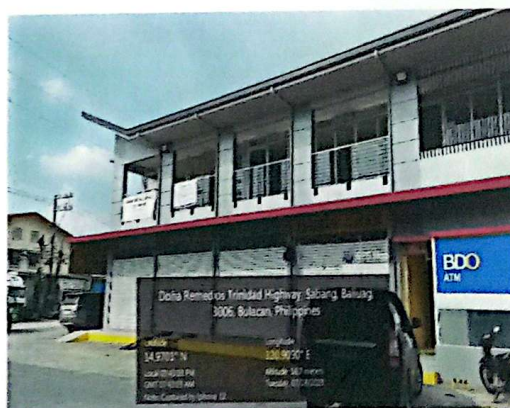
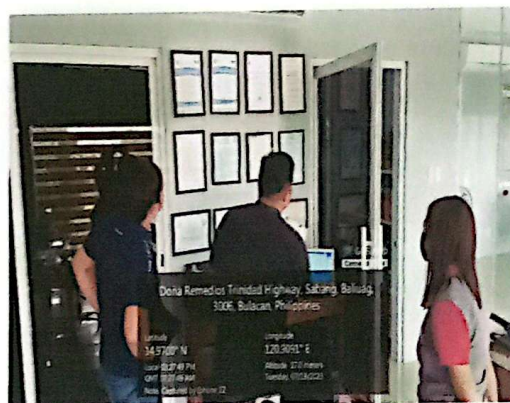

Findings:

- Lack of environmental permits such as Certificate of Non-Coverage (CNC), Environmental Compliance Certificate (ECC), Discharge Permit (PCO) Pollution Control Officer, (PTO) Permit to Operate air pollution and hazardous wastes generator I.D

In regards with the above-mentioned issue, MENRO cited the following recommendations to address the said issue. The lists of recommendations are as follows:

Recommendations:

- Provide at least three trash bins with label for proper solid wastes segregation
- Secure environmental permits such as CNC (Certificate of Non -Coverage), Environmental Compliance Certificate (ECC), Discharge Permit (PCO) Pollution Control Officer, (PTO) Permit to Operate air pollution, hazardous wastes generator I.D, and Cert. of final disposal for toxic and hazardous wastes to the EMB (Environmental Management Bureau)
- The permit holder shall submit quarterly self- monitoring report to City-ENRO

Also, we will conduct quarterly monitoring on the said Establishment to ensure their compliance with the following environmental ordinances:

- RA 9003- Ecological Solid Waste Management Act of 2000
- RA 8749- The Philippine Clean Air Act
- RA 9275- The Philippine Clean Water Act
- RA 6969- Toxic Substances & Hazardous & Nuclear Waste Control Act

** We do advise to make an urgent response in addressing this matter as soon as you received this inspection report. Failure to comply with the recommendations given above will result to restricted operation or much worse, closure of the business.*
