

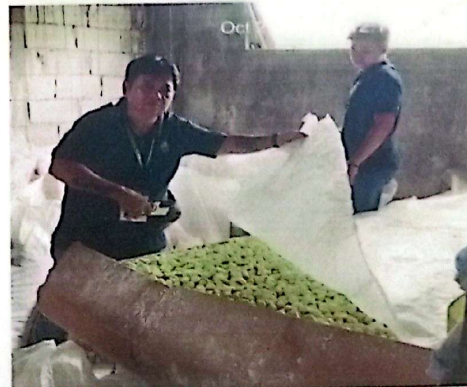

Findings:

- Without Materials Recovery Facility (MRF)
- Mixed wastes
- Improper storage and disposal of solid wastes
- Without trash bins for proper segregation of solid wastes
- Large volume of solid wastes approximately 6 trucks were generated per month
- Lack of environmental permits such as Certificate of Non-Coverage (CNC) and hazardous wastes generator I.D

In regards with the above-mentioned issue, MENRO cited the following recommendations to address the said issue. The lists of recommendations are as follows:

Recommendations:

- Establish Materials Recovery Facility (MRF) for proper storage of solid wastes
- Practice proper segregation of solid wastes
- Provide trash bins with proper label (Biodegradable, Non- biodegradable and Recyclable)
- Provide accredited private hauler for proper transport and disposal of solid wastes
- Secure environmental permits such as Certificate of Non-Coverage (CNC) and hazardous wastes generator I.D to Environmental Management Bureau (EMB) for your compliance

Also, we will conduct quarterly monitoring on the said Establishment to ensure their compliance with the following environmental ordinances:

- RA 9003- Ecological Solid Waste Management Act of 2000
- RA 8749- The Philippine Clean Air Act
- RA 9275- The Philippine Clean Water Act
- RA 6969- Toxic Substances & Hazardous & Nuclear Waste Control Act

** We do advise to make an urgent response in addressing this matter as soon as you received this inspection report. Failure to comply with the recommendations given above will result to restricted operation or much worse, closure of the business.*
