- Trash bins has no proper label
- Without accredited hauler and certificate of final disposal for liquid wastes
- Lack of environmental permits such as Hazardous Wastes Generator I.D and discharge permits

- Trash bins has no proper label
- Without accredited hauler and certificate of final disposal for liquid wastes
- Lack of environmental permits such as Hazardous Wastes Generator I.D and discharge permit
- No smoke was seen because the operation time was changed.

Others:

- The average production of raw beans is 7 to 8 sacks (25kls./sack) per day.
- Operation hours starts at 3:00pm until 2:00am.
- The establishment already designate a Pollution Control Officer (PCO)

In regards with the above-mentioned issue, MENRO cited the following recommendations to address the said issue. The lists of recommendations are as follows:

Recommendations:

- Trash bins must have proper label for proper segregation of solid wastes
- Accredited hauler for the proper disposal of liquid wastes and secure a certificate of final disposal
- Secure environmental permits such as Hazardous wastes generator I.D and discharge permit to the EMB (Environmental Management Bureau)
- Air quality test is advice to check the quality of smoke coming from the chimney.

Also, we will conduct quarterly monitoring on the said Establishment to ensure their compliance with the following environmental ordinances:
