Findings:

- With business permit
- Has 2 trash bins
- Without Material Recovery Facility (MRF)
- Mixed wastes
- Without grease trap
- Liquid wastes from kitchen sink are flowing to the canal
- Has septic tank
- Without environmental permit such as Certificate of Non-Coverage (CNC), Discharge Permit, Hazardous wastes generator I.D and Pollution Control officer

In regards with the above-mentioned issue, MENRO cited the following recommendations to address the said issue. The lists of recommendations are as follows:

Recommendations:

- Practice proper segregation of solid wastes
- Provide additional trash bins with label for proper segregation of solid wastes
- Establish mini-Material Recovery Facility (MRF) for proper storage of wastes generated
- Install grease trap to collect the oil and grease generated
- Collected oil and grease from the grease trap must be dispose through an accredited hauler
- Submit septage and plumbing plan to check the flow of liquid wastes generated
- Secure environmental permits such as Certificate of Non-Coverage (CNC), Discharge Permit, Hazardous wastes generator I.D and Pollution Control officer to the EMB (Environmental Management Bureau)
- Train a Pollution Control Officer to help monitors and reduces pollution to protect public health.
- The permit holder shall submit quarterly self- monitoring report to City-ENRO

Also, we will conduct quarterly monitoring on the said Establishment to ensure their compliance with the following environmental ordinances:

- RA 9003- Ecological Solid Waste Management Act of 2000
- RA 9275- The Philippine Clean Water Act
- RA 6969- Toxic Substances & Hazardous & Nuclear Waste Control Act

** We do advise to make an urgent response in addressing this matter as soon as you received this inspection report. Failure to comply with the recommendations given above will result to restricted operation or much worse, closure of the business.*
