Dear Mrs. Tolentino,

Good Day!

We, the residents of the Inner Munsayac Street from Barangay Calantipay, are writing a letter of complaint to report on the inappropriate activities done by one of our neighbours.

For the past 3 months our neighbour, who is seen to be plastic recyclers, have been improperly disposing of said plastic materials through the method of burning by using small tin containers. This has resulted to frequent sightings of thick dark smoke accompanied by toxic foul-smelling fumes of burning plastic, which is observed both from their house and the rice fields; bundles of plastic can be seen being dumped and burned in the rice field. Such occurrences are often random and discretely done by the people responsible.

The accumulated plastic materials have resulted to disturbances in the form of toxic fumes, foul odor, and flies. Many registered residents, more than 120 individuals (including 25 families), are affected by these consequences. These activities have made everyone worried as these are not only addressed as health and environmental hazards, but also a fire hazard that may endanger the surrounding community and environment.

In line with this, we hope to hear from you within the next 72 hours, VIA LETTER, your answer to our complaint and hope that actions be done to put an end to these inappropriate activities.

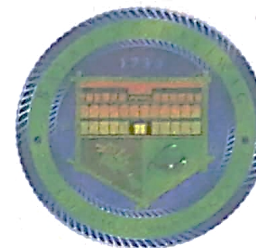
